- launched new funds for <u>pulmonary fibrosis</u>, <u>hepatitis C</u>, <u>urea cycle disorders</u> and, most recently, <u>cystic fibrosis</u>;
- introduced an Instant Approval process to give patients immediate access to their grant;

PROGRAM ENHANCEMENTS

There was little time for rest over the summer as the team worked hard to prepare for and implement the latest enhancements to our program. As we announced in late spring, we rolled out an improved application that allows re-enrolling grant applicants to apply online. We didn't stop there! Later in the summer, we announced that we now offer instant approval for eligible grant applicants. The enhancement allows patients and providers to learn if they are approved for a HealthWell grant immediately upon electronic submission of their application or while speaking with a HealthWell representative. Through our recent enhancements and streamlined application process, we've tried to make it as convenient as possible to apply for and manage your grant online. Whether you are a new or re-enrolling grant applicant, be sure to visit our <u>Diseases and Medications</u> page and click on an individual disease area to determine what type of assistance is offered (copayment or premium). Once you've determined whether you are eligible for assistance, you can reenroll or apply for a new grant through our online application. Through the generosity of our donors, we were proud to announce the launch of four new funds this year! In the spring, we opened our pulmonary fibrosis and hepatitis C funds. Through these funds, we are now able to offer copayment assistance to patients living with pulmonary fibrosis and hepatitis C. In August, we were excited to open a new fund to provide copayment relief to patients living with urea cycle disorders, a genetic disorder that results in a deficiency of one of the six enzymes in the urea cycle. Most recently, we opened the cystic fibrosis fund to assist with out-of-pocket costs for treatment for cystic fibrosis patients.
