2009 highlights

- Welcomed Mary P. Sundein as HealthWell's new Executive Director
- Granted more than \$137 million in awards to 46,900 patients

For many Americans, having health insurance does not necessarily mean they can afford the critical medical treatments they desperately need.

It is estimated that anywhere from 25 million to over 40 million Americans are underinsured, meaning they have insurance but still cannot afford out-of-pocket costs for prescription drugs, copayments, coinsurance, deductibles and health insurance premiums. ***More than one in five Americans has been forced to abandon medical treatment for financial reasons.***

They may choose, for example, to pay for lifesaving therapies instead of paying a mortgage. They may cut pills in half to make them last longer or give up life-sustaining treatment to send a child to college or pay for other family expenses. They may face financial ruin; approximately 60% of bankruptcies in the United States are related to medical expenses.

The HealthWell Foundation® is an independent, non-profit organization that reduces financial barriers to care so that patients can focus on what is most important: getting better. We provide financial assistance to underinsured patients who are living with chronic or life-altering illnesses, such as cancer, asthma and autoimmune disorders, helping them afford their prescription drug copays, health insurance premiums and other out-of-pocket costs.

Since 2004, we have helped more than 100,000 patients afford their medical treatments and lead healthier, more fulfilling and productive lives.

From our Board President

The year 2009 was a major watershed for the country and for the HealthWell Foundation.

At the national level we watched the health care reform debate in Washington that ultimately culminated in March 2010 with enactment of the Affordable Care Act. HealthWell's commitment to helping the underinsured had us follow the reform debates very closely to see how the outcome might help our beneficiary population. While it seemed likely that reform would be terrific for many of the approximately 47 million uninsured in America, we needed to understand what it might do for the estimated 25 to over 40 million underinsured.

For this reason, in September 2009 the Foundation sponsored a round table to draw attention to the continuing crisis of the underinsured, along with the related challenges of reducing financial barriers to care. Held at the National Press Club in Washington, DC, "Health Care in America: What About the Underinsured" featured a panel of highly-esteemed health policy analysts and stakeholders, each representing a different perspective in the health care reform debate. Jonathan Cohn, Senior Editor of the New Republic, moderated the discussion. Each speaker emphasized the importance of a reformed health care system that adequately addresses the underinsured as well as the uninsured in our country.

We understood that in all likelihood the enactment of reform, in light of the proposals under active discussion by the end of 2009, would not be as beneficial for the underinsured as we had hoped. Even with final enactment we expect to continue to see an enormous, and probably increasing, demand for our financial support, and hope that our very generous donors will understand that the need for the Foundation will be with us for a long time to come.

The Foundation took a major step forward itself in 2009 when its Board had the pleasure of appointing Mary Sundein as the Executive Director. Mary brings to the Foundation strong skills in the areas of management, communications and relationship building. She has deep ties to the health care delivery and biopharmaceutical areas, and understands in a very direct way the needs of our beneficiaries and the importance of our donors. She has already begun to demonstrate her very strong leadership skills as HealthWell finds new ways to promote its core mission in a changing world.

We look forward to 2010 and continue to hope that, as health care reform evolves, the needs of America's underinsured are better heard and addressed.

As the recession deepened in 2009 leaving an increasing number of Americans without adequate health coverage, demand for HealthWell's services grew at an unprecedented rate and challenged our infrastructure, staff and donors as never before. Our volume of grants to patients jumped 40 percent from 2008 to 2009. Even more telling is the number of patients we served last year. Since the HealthWell Foundation opened its doors in 2004, we have awarded grants to more than 100,000 patients. Close to half of those, or 46,900 patients, were assisted in 2009 alone. **Clearly, the need for copayment assistance is not diminishing and will, in fact, remain strong throughout the next decade.**

HealthWell also welcomed several new donors and opened a new fund for patients with brain tumors. But our work is really just beginning. To meet rising patient demand, we will need the continued support of our exceptional pharmaceutical industry donors and committed, multi-year support from the broader health care arena. Many organizations in the industry refer patients to HealthWell for copayment and premium assistance without providing any financial support. By working together, and each giving their share, we could offer thousands of patients a true chance at positive health outcomes and proper disease management—a goal that we are powerless to achieve alone.

To our current donors, I thank you for giving us an opportunity to say "YES" 46,900 times

last year when patients contacted us for assistance. As a result of your generosity, we were able to provide grants and pharmacy cards so patients could receive life-saving and life-supporting treatments. **And despite the recession, and health care reform that directly impacted the bottom line for every pharmaceutical company in America, not a single HealthWell donor discontinued support to our program in 2009.**

Our work was noticed outside the health care industry as well. *Forbes.com* gave the HealthWell Foundation a 100% Efficiency Rating in 2009, and named us the 12th Most Efficient Charity in America. Whether your donation to HealthWell is measured in ones—or in millions—you can be assured that every possible dollar is being given directly to the patients we serve.

We are blessed with a dedicated Board of Directors, each an expert in their respective professions, exceptional and loyal donors, and the hardest working staff of seven I have ever seen. Helping Jacob breathe



By the time he was seven, Jacob suffered from allergies and asthma severe enough to limit his growth, cause him to miss school and prevent him even from going out to play. The doctors prescribed a new medication. Within months, Jacob’s life turned around. He was active, gaining weight, attending school—in short, living the normal life of an eight-year-old boy. Then, at the start of this year, his mother went to the pharmacy to refill the prescription and found out her deductible had tripled.

“I could barely pay it before, there was no way I could now,” his mother recalls. “It was either buy food for my three children or buy his medication. It was a difficult choice, and one I cried about—but I could not refill his medication.”

Jacob began deteriorating quickly. He was unable to play with his friends or brothers, ride his bike or engage in any physical activity at school. Jacob and his mother learned about the HealthWell Foundation from their doctor and applied immediately. Their request for support was approved just in time, before his physical condition deteriorated further.

“Jacob is a funny, witty, loving, active nine-year-old boy,” his mother recently told us. “But when he’s not on his asthma treatment he spends a lot of time inside, missing out on life and feeling left out and lonely. Your foundation has helped him to be able to be social again... He went on a two-hour bike ride with his Boy Scout troop and did not even need an inhaler. That would not have happened without the kindness of HealthWell.”

Every day, HealthWell helps more than 200 adults and children like Jacob pay for life-changing medical treatments ranging from asthma medications to chemotherapy. We work closely with patients to find the best solutions to meet their needs, and re-enroll many patients for multiple years to ensure continuity of care.







To ensure continuity of care, we award a grant to a patient for an entire year. However, not every patient uses his or her full grant. In these cases, we reallocate the unused grant to other patients in need as quickly as possible. This means we award some of our grant dollars more than once. In fact, in 2009, we re-awarded \$57 million in grants to other patients in need.
